

AXIS COVER SYSTEM

LIMITED WARRANTY

YEARS

MasterSpas, LLC. ("MasterSpas") warrants the Axis Cover System ("Cover") against defects in workmanship and/or material to the original retail purchaser from the date of original retail purchase. The Axis Cover System (Outer Cover Skin, Insulating Bag and Support Beams) is warranted to not deteriorate beyond usefulness due to defects in material or workmanship for a period of 3 years. The cover should be inspected before use and periodically thereafter for premature wear or deterioration that could result in unsafe conditions. MasterSpas will replace defective parts or components in accordance with the provisions of this limited warranty.

EXCLUSIONS

This Limited Warranty is enforceable only by the original retail purchaser and covers the parts of the Cover only. Any and all other expenses associated with a warranty claim including onsite inspection, removal, replacement or transportation labor provided by a dealer or service center are the sole responsibility of the original retail purchaser. Normal wear, weathering, discoloring and/or fading is considered normal and excluded from this limited warranty coverage. Damage caused to the Cover or the failure of the Cover due to the following are specifically excluded from this Limited Warranty.

- Defects or damage relating to any other components or parts that are not specifically part of the Cover.
- Failure to maintain swim spa water chemistry resulting in rapid material discoloration, fading and/or deterioration. (i.e. PH outside of 7.2-7.6 and chlorine or bromine levels outside of 2.0-4.0ppm; see swim spa owner's manual for specific water maintenance requirements).
- Failure to maintain the Cover in accordance with the provided Cover installation instructions.
- Negligence, abuse, misuse, vandalism, accidents, natural disasters, high winds, extreme weather conditions, acts of war or acts of God.
- Scrapes, rips, tears, punctures or similar damage caused by the cover being dragged across abrasive objects or coming in contact with abrasive or sharp objects.
- Scrapes, rips, tears, punctures or similar damage caused by the cover being rolled up with foreign objects present on the top of the cover (i.e. sticks and small branches).
- Ripped, torn or damaged stitching, cover skin material, handles or locking straps due to failure to disconnect locking straps before opening, failure to remove snow, ice or other items from top of cover before opening or excessive force when opening, closing, moving or lifting the cover.

- Ripped or torn stitching cover skin material along perimeter skirt due to improper use of skirt to lift, move or roll cover open/shut or failure to fold up corner skirt before rolling cover open.
- Repairs or alterations to the Cover by parties other than MasterSpas Inc.

WARRANTY REGISTRATION AND WARRANTY CLAIM PROCEDURE

In the event of a warranty claim of a defect in the materials or workmanship of the Cover covered under the provisions of this limited warranty; the original retail purchaser must first notify, in writing, the retail dealer who sold the Cover within ten (10) days of the initial discovery of defect. Detailed photos of the Cover along with the Cover production tag, located on the underside of the cover skirt, should be provided for inspection and determination of the alleged warranty claim. If the retail dealer does not provide support, then the purchaser should contact MasterSpas' customer service department, at customerservice@masterspas.com or provide written notice of the defect at the address below. Within a reasonable time of receipt of the notice of the warranty claim, valid proof of purchase and detailed photos of the alleged claim; MasterSpas will inspect detailed photos of the Cover provided by the retail purchaser or, if necessary, arrange inspection of the Cover through the retail dealer or service center to determine if the alleged defect is covered under this limited warranty. If it is determined that claim is not covered by this limited warranty, the cost of replacement is the sole responsibility of the purchaser. If it is determined that the defect is covered under this limited warranty; MasterSpas, through the retail dealer or an approved independent service center, will authorize and provide replacement component(s) for the Cover or replace the Cover. Replacement items would be picked up at the retail dealer or service center location once received or shipped directly to the retail customer. Any labor costs provided by a retail dealer or service center to inspect, repair or replace the cover for the retail purchaser along with any freight and shipping costs of the replacement component(s) or Cover are the responsibility of the retail purchaser.

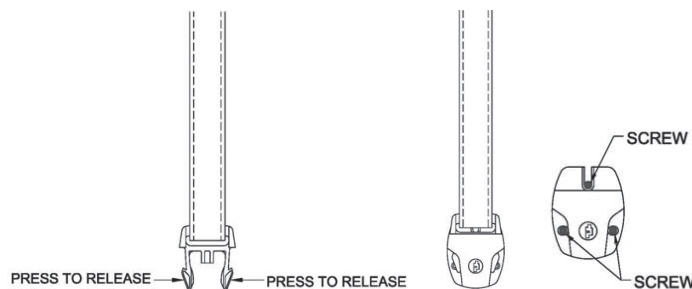
INSTALLATION INSTRUCTIONS

INSTALLATION INSTRUCTIONS

1. Position the spa cover on the Swim Spas.
2. While holding the buckle against the outer cabinet, release the strap from the buckle, and mark the three mounting locations.
3. Use the supplied screws to secure the buckle onto the outer cabinet.
4. Repeat Steps 2-4 for the remaining straps.

NOTE: Cover buckles/locks must be installed and should always be secured any time spa is not in use

AS NEEDED: Use adjustment buckle in the lock strap to lengthen or shorten strap for both mounting the lock and also ensuring strap is snug when cover is closed and locked.



WARNING:

AVOID RISK OF DROWNING

1. Remove Cover completely before using the swim spa to avoid possible entrapment.
2. Always secure Cover locking straps when the swim spa is not in use to avoid unattended entry. (SEE COVER INSTALLATION INSTRUCTIONS).
3. Do not allow children into the swim spa unattended.
4. Do not stand or sit on the Cover as it is NOT designed to support extra weight.
5. Inspect the Cover frequently for deterioration or damage.
6. Do not allow standing water to accumulate on top of the cover as this could pose a drowning risk.
7. Failure to follow these directions could result in drowning or personal injury.
8. This cover is constructed in accordance with ASTM F-1346-2010 guidelines.
9. Should the ASTM labeling become damaged or illegible, contact MasterSpas at the address listed at the end of this document for a replacement label.
